9.1 Actions Outstanding: - Kim

- 9.1a The safety magnets are ready for distribution by mail. Kim is working with Canada Post in Ayr to try and narrow down some postal addresses for Brant Count residents that get their mail through Drumbo and Ayr.
- 9.1b We also had discussed replacing the "Citizen's on Patrol" signs at the four entrances to the village. Now that we no longer go on foot patrols, discussions resulted in the feeling we should change those signs to something more general. Kim is working on a design and will email her findings to us all so we can vote on our preference. Then she will get a quote on the sign. We will be applying for funding for this to the County of Brant.

9.4 Magnet Update

The magnets have been printed and a sample of the magnets were distributed. They will be mailed out shortly.

9.5 Lock It & Lose It –follow-up - Constable Conrad Vitalis lead a discussion on this idea. Since we can no longer go onto private property, he suggested a new idea.

Safety Audit Patrols –

- whereby our committee/group would accompany the OPP on a street
- the purpose would be to take notice of various residences and what they could do to make their property safer.
- We would record our findings and make note of them on our Facebook page.

Lock It & Lose It – con't

- Any residents that come out wondering what we are doing will be given a pamphlet about our work and our meetings.
- It was felt we might have better visibility this way and the word would spread about our work.
- This way we could do several smaller audit patrols in a year.
- Also, if there are any vehicles parked on the street with valuables visible, they will be left with a pamphlet suggesting they keep valuables 'out of sight'
- These audit patrols would be held Saturday or Sunday in daylight hours. Suggested dates were Jan 14th and Jan 29th from 9:30am to 11:00am
- Auxiliary officers would be attending as well
- These audit patrols, would provide information for a subsequent speaker on Home Safety
- Kim and Conrad will collaborate on the hand outs

9.6 Feb & April 2023 Public Meetings:

- Public Meeting February 15th will be on safeguarding, where we will take info from the audit patrols and use as information for discussion
- April 19th tentative plans for Paul Davis speaking on Cyber Media. Cost \$1500.00 + HST. Kim will investigate into grants/funding for this project. Perhaps consider partnering with Paris group.
